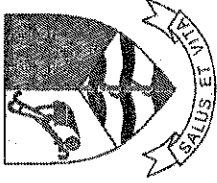

Race	100% Black owned = 5 points, more than or equal to 51% black owned = 3 points, less than 51 % youth owned = 1 point,	Maximum points of 5
Disability	100% people with disability owned = 5 points, more than or equal to 51% people with disability owned = 3 points, less than 51% people with disability owned = 1 point	Maximum points of 5
