SUBJECT: INVITATION TO COMMENT ON THE DRAFT 2022/23 IDP/BUDGET REVIEW PROCESS PLAN

In terms of the Local Government: Municipal Systems Act No 32 of 2000, in compliance with Section 34 of the aforementioned Act, the Municipal Council is required to conduct an annual Integrated Development Planning and Budget review.

Section 21(1)(b) and Section 53 (1)(b) of the Local Government: Municipal Finance Management Act No 56 of 2003 requires the Mayor of the Municipality to at least 10 months before the start of the budget year table in the Municipal Council a time schedule outlining key deadlines for preparation, tabling, approval and review of the annual budget.

Section 16(1) (a)(i) provides that a Municipality must develop a culture of Municipal governance that complements formal representative government with system of participatory governance and must for this purpose coordinate IDP Representative Forum meetings.

As part of the South African Government's response to the COVID-19 pandemic, President Cyril Ramaphosa moved the country to Adjusted Level 4 on 27 June 2021 and put in place further restrictions to combat the spread of the virus. The restrictions include prohibiting gatherings of more than 50 people.

Under level 4 regulations, all the gatherings are prohibited except for funerals, adhering to a maximum of 50 people and social distancing guidelines. Gatherings for the subject meeting is therefore prohibited. (Remove this paragraph)

It is in light of the above background that the Office of the Municipal Manager invites your inputs and comments on the Draft 2022/23 IDP/Budget/PMS process plan.
