Nagenoeg 14 000 deelnemers het aan hierdie 52ste Midmar-Myl deelgeneem. Die Midmar-Myl word gesien as die grootste oopwater-swembyeenkoms ter wêreld. Die top mansswemmer vir die dag was Louis Clark van New Zealand in 'n tyd van 19 minute en 07 sekondes.

Van Zyl is baie tevrede met sy vertoning. Die Midmar-myl was sy eerste oopwater swemdeelname. Hy het al in die verlede verskeie half-Ysterman-kompetisies voltooi en neem gereeld deel aan fietsry-kompetisies.
