- Freedom to engage in business activities with the necessary permits
- Designation of business areas and sites to promote inclusive economic development
- Issuing and management of business permits
- Proactive steps by the municipality to support township businesses, including capacity building and access to infrastructure and markets
- Registration and permitting processes for business activities
- Prohibitions and restrictions to ensure orderly business operations
- Enforcement mechanisms and penalties for non-compliance
