**EXPRESSION OF INTEREST FOR SUB-CONTRACTING:**

Local Emerging Contractors are hereby invited for the expression of interest in sub-contract work **(Labour only)** on the replacement of faulty water meters in Bela Bela Town and Township, Masakhane and Pienaarsrivier and the installation of new water meters in Bela Bela X9. The water meters will be provided by the Service Provider, **Studio Martini Ingegneria**.

Prospective sub-contractors who comply with the following requirements are eligible to submit Bids:

- Submit Company registration documents.
- Submit a valid and original tax clearance certificate and a SARS tax compliance verification pin on the SARS letterhead. In the case of the Joint venture, such documents must be attached for all parties.
- Submit proof of registration with the **Central Data Base** (CSD) of the National Treasury, and
- Submit written proof of registration with the CIDB, in an appropriate Contractor grading designation of **1CE** (category) only.
- Submit a municipal rates and taxes account or proof of residence only for Bela Bela Local Municipality. The bidder and/ or any of its directors must not be in arrears for more than 3 months for municipal rates and taxes owed to the Bela Bela Local Municipality.

There will not be a compulsory briefing session due to the current National Lockdown **Regulations issued in terms of section 27(2) of Disaster Management Act/ 2002** that must be adhered to at all times.
