The Municipality shall adjudicate and award bids in accordance with the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) as well as the Bela Bela Local Municipality Supply Chain Policy. Tenders received will be evaluated in terms of the 80/20 Preferential Point System goals as prescribed in the amended Preferential Procurement Policy Framework Act (No 5 of 2000). The specific goals will be allocated as indicated in the table below:

<b>Category of persons</b>	100% Youth owned = 5 points, more than or equal to 51% Youth owned = 3 points, less than 51% Youth in shareholding = 1 point Maximum of 5 points
<b>Gender</b>	100% Women owned = 5 points, more than or equal to 51% Women owned = 3 points, less than 51 % Women owned = 1 point Maximum points of 5 points
<b>Race</b>	100% Black owned = 5 points, more than or equal to 51% Black owned = 3 points, less than 51% Black owned = 1 point, Maximum points of 5 points
<b>Disability</b>	100% people with Disability owned = 5 points, more or equal to than 51% people with Disability owned = 3 points, less than 51% people with Disability owned = 1 point Maximum points of 5 points

The Municipality reserves the right to negotiate further conditions and requirements with a successful bidder in compliance with Municipal Supply Chain Management Regulations and have the right not to appoint.
