SCOPE OF WORK

1. Disassemble existing panels (168)
2. Check and inspect internal bracing
3. Supply and fit new sealant and rubbers
4. Supply and fit new galvanised panels to fit existing
5. Assemble panels
6. Disinfect

Proposal shall include the supply and installation of all material, labour and site establishment

SPECIFICATIONS

1. Replace existing panels where necessary
1m x1m hot dip galvanised
 - Bottom panels, 1st -, 2nd- & 3rd side panels 3mm thick (x 20)
 - 4th- & roof panels 2mm thick (x 30)

2. Pre- punched rubber gasket between panels with non- toxic sealants to achieve maximum sealant of the tank.
3. Bolts, nuts and washers - check existing and replace if necessary
Hot dipped steel galvanised M16 bolts, nuts and washers for internal and external use (x 500)
