Tenders received will be evaluated in terms of the 80/20 Preferential point system as prescribed in the amended Preferential Procurement Policy Framework Act (No 5 of 2000). The specific goals will be allocated as indicated in the table below:

Disability	100% people with Disability owned = 5 points, more or equal to than 51% people with Disability owned = 3 points, less than 51% people with Disability owned = 1 point Maximum points of 5 points
